Application Guide

Responsibilities of exhibitors: All exhibitors are responsible for the arrangement, entry and exit of accepted art works. During the exhibition, exhibitors or designated persons **must** be present for seven exhibition days to introduce the works. Each artist/designer is limited to submit five pieces of works, curator ten pieces of art works and filmmaker two piece of art work. The artist authorizes the company to upload images of works and sell works on Shu Xin Tang App, www.guyuartshow.com, Shuxintangshengartspace official Wechat account, and Shuxintangshengartspace Wechat Mini Program. The company owns first right to be authorized commercial use of IPs of all final exhibited artworks. The exhibition space is approximately 800 square meters. All works are arranged and distributed by the curatorial team of GUYU Art Show.

After entering all required information, please save the application in PDF version, and upload the file and high res images of the artworks to the application webpage on the official website. Exhibition date: **starting April 20, 2021 (on SHUXINTANG App)**

July 10 – August 12, 2021 (offline exhibition in SHENZHEN)

On **June 9, 2021**, admitted artist must attend installation meeting in Nanshan Qu, Shenzhen

Consignment agreement: the exhibitor agrees that the exhibited works will be sold by the organizer of GUYU Art Show (Shenzhen Shuxintang Culture and Art Communication Co., Ltd.) during the exhibition period **until December 31st, 2021**, and **30%** of the sales will be collected by the organizer of GUYU Art Show (Shenzhen Shuxintang Culture and Art Communication Co., Ltd.). The sold works shall be settled by the Finance Department of the organizer of GUYU Art Show (Shenzhen Shuxintang Culture and Art Communication Co., Ltd.).
